LOCATION: The festival will be held on the grounds of Heron Creek Middle School (6501 W. Price Blvd., North Port).

SET UP & PARKING: Vendor setup is from 11:30 am to 1 pm on Sat., Nov. 12, 2011. All setup must be completed by 1 pm and vendor vehicles removed from the festival area for safety reasons. Reserved vendor parking will be available.

FESTIVAL HOURS: The festival will operate from 2pm to 6 pm. All booths are required to remain intact during that time. You will be allowed to shut down your booth during festival hours if necessary, however, no vendors will be permitted to breakdown and physically leave the festival area prior to the 6pm closing time. Due to safety concerns, vehicle access to the festival area will remain closed from the 2pm to 6pm time period.

SPACES: Vendor spaces are 10'x10' each and are uncovered—please bring your own tents, tables, chairs, canopies, etc.

FOOD VENDORS: Food vendors will be permitted to sell the menu of their choice and serve drink products (excluding alcoholic beverages). Please specify menu items on the front of the form. Vendors must comply with the standards listed on the 'Fire and Life Safety Requirements' sheet as established by City of North Port (copy available at www.KidFestNorthPort.com under 'Applications').

CANCELLATION/NO-SHOWS: Refunds cannot be given for cancellations and no-shows.

VENDOR ETIQUETTE: Vendor displays must stay in their assigned spaces. No direct solicitation of sales or loud yelling out from spaces will be permitted. Vendors must arrange their booths so as to not interfere or obstruct view of other booths.

SAFETY: Safety is important to all participants of the festival. It is imperative that you review the 'Fire and Life Safety Requirements' sheet that will be sent with your vendor information package. Vendor spaces will be inspected for compliance—please note that the North Port Area Chamber of Commerce is not responsible or liable for the failure of vendor compliance with these requirements and fees will not be refunded if a vendor fails inspection.
